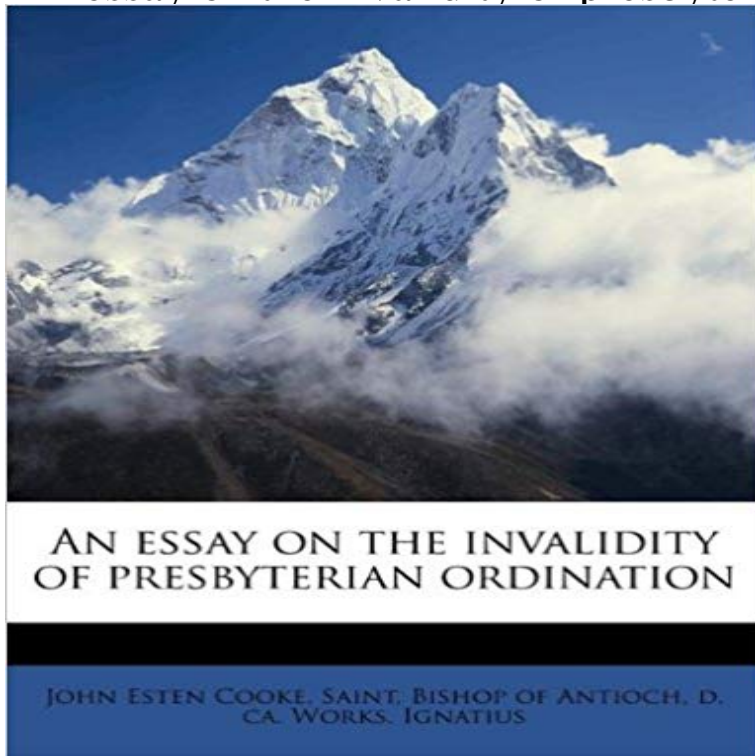


An essay on the invalidity of presbyterian ordination
